This would equalize treatment of burials in cemeteries administered by the National Park Service with the practice of cemeteries administered by the National Cemetery Administration.

Under current practice, the National Cemetery Administration processes requests for burial of deceased spouses and dependent children in national cemeteries on a case by case basis.

Gaye passed away at age 44 on April 1, 1984 when he was shot to death by his father after an argument.

[Sergeant First Class Alwyn Crendall](#) was awarded the Silver Star for his heroic actions after his vehicle struck an improvised explosive device in the Iraqi province of Salahuddin on October 17, 2005. He passed away three weeks later. Despite serious injuries, including second and third degree burns on over 72% of his body, Crendall saved the lives of six fellow soldiers. Sergeant First Class Cashe’s Silver Star is currently under consideration for an upgrade to the Medal of Honor. Should that occur, Crendall would be the first African-American Medal of Honor recipient since 1969.
